**Space Reservations:** A 50% (\$225) deposit is required to secure your exhibit space.

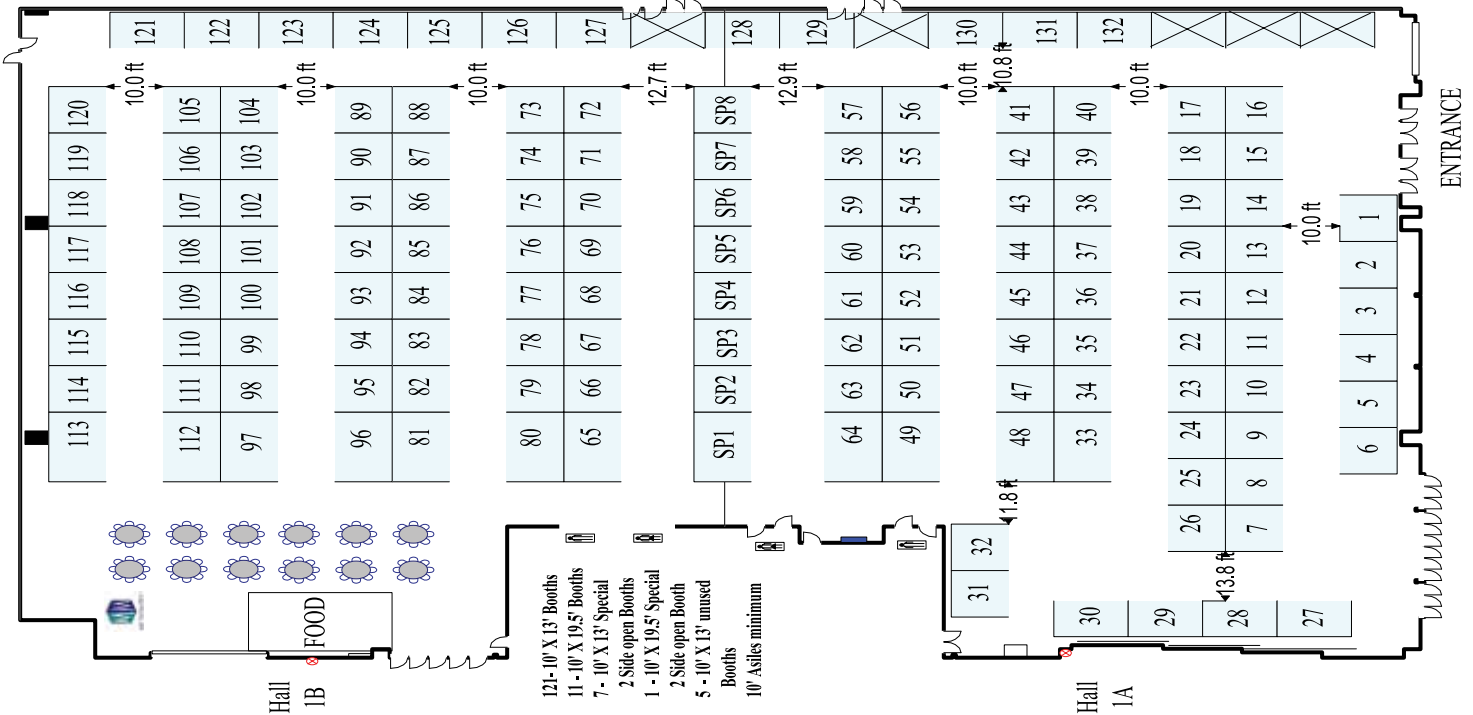
